## **Getting Your Fair Share**

There are currently over **1,000** grant programs administered by **26 federal agencies** providing more than **\$400 billion** to states and local governments through grants, formula allocations and other payments



## How Federal Funds Flow

- Formula funds are distributed by the federal government to state and local governments based on population and crime statistics and have public safety technology equipment as an allowable use (generally smaller sums)
- Competitive funds require the completion of an application in order to receive them (for larger sums and more innovative projects)





## Who is Funding Smart Technology Purchases?

Funds are primarily available from:

Department of Justice Department of Homeland Security Department of Housing and Urban Development Department of Transportation

- There is no penalty for pursuing multiple federal funding sources
- The majority of these funding opportunities do not have a match requirement.

## Federal Funding is Always in Season

- Spring Competitive grants submitted and engage Congressional delegation for political support
- Summer Submissions of formula funding budgets and competitive grants

Development of next fiscal year federal funding roadmap

Funds awarded and work to expedite drawdown and expenditure of awarded funds

• Fall Congress passes appropriations bills and information on funding levels for projected grants becomes available

Arrange calls and meetings with relevant federal agency program officers to pitch your project while developing your relationships with key agency officials and staff

Line up research and community partners

Winter Competitive grant solicitations released and final drafting begins

Formula funding levels for DHS and DoJ grants to communities are released and budget justifications drafted



### Funds with Fewer Forms! (or how to use old money or someone else's money)

- Reprogram unspent formula funding or funds that were awarded through competitive grants
- Make creative use of formula funds know the allowable uses and leverage local politics
- Follow the money and partner with non-muni grantees (universities, public housing authorities, etc)



## **Key Indicators of Funding Success**

- Have a plan to improve quality of life for your residents using smart technology as a tool (its about the use case, not the shopping list)
- Show a local commitment to this effort, including community partners, both government and non-government
- Have early conversations with federal program managers
- When needed, identify and establish researcher partnerships early
- Compile data to support your request
- Arm your federal elected officials to advocate for you
- Demonstrate a history of solid stewardship of grant funding (funding begets funding)
