



Range Rules

ALWAYS Keep the Four Fundamental Rules of Firearm Safety.

ALWAYS treat all firearms as if they are loaded.

ALWAYS keep your finger off the trigger and outside of the trigger guard until ready to fire.

ALWAYS be aware of your surroundings especially what is in front and behind your target.

RULES & PROCEDURES:

1. "CEASE FIRE"- If you HEAR:

- Immediately remove your finger from the trigger.
- Safely unload your firearm, lock open your action and lay your firearm down point down range(barrel).
- Step back from the firing line and await for the "All Clear" instruction from the RSO before you re-approach the firing line.
- If you observe an unsafe condition notify a staff member immediately.

2. FIREARMS: Before entering facility:

- Must be, unloaded, magazines removed, secured, and cased or holstered.
- Licensed Conceal Carry Firearms, **MUST REMAIN CONCEALED** unless at the firing line.

3. INSPECTIONS: Ammunition & Firearms:

- All Firearms and ammunition must be DISCLOSED.
- **All Ammunition shot in Range must be original manufactured ammunition.**
- NO HOME BAKED, RELOADED AMMUNITION.

4. AMMUNITION NOT ALLOWED:

- Incendiary, tracer, armor piercing, frangible, BBs, steel core, bird shot (shotguns may only shoot rubber projectiles), NO straight exposed lead bullets, and no black powder.
- **ALL HANDGUN ammo MUST be brass casing. NO aluminum or steel casings.**
- Range 406 firearm rentals must only use Company ammunition(ammo we sell).

5. EYE's & EARS:

- Must be worn prior to entering the range and must be worn at **ALL TIMES.**

PROPER FOOTWEAR & CLOTHING: No loose clothing or high heels.

6. VESTIBULE:

- Only one door is to be open at one time, while entering or exiting the range.

7. NO FOOD OR BEVERAGE IN RANGE

- Shooters should wash hands after shooting.

8. MEDICAL DISABILITIES:

- Please notify the Range Safety Officer (RSO) so that we can assist you.
- No pregnant women in the range.

9. Age:

- Anyone under 21 must be accompanied by an Parent or Guardian to shoot handguns.
- Shooters of long guns may be 18 years unaccompanied.
- Minimum age is 12 years old, Double ear protection is recommended for children. Firearms must be appropriate to the shooter.

10. SAFETY FIRST:

- Know your firearm and how it operates!
- If something is unfamiliar ask the staff for help before entering the range.

11. UNCASE and CASE FIREARMS:

- In shooting booth area only at the firing line.
- You are welcome to store the case in the ready area while you shoot.
- Make sure before casing the firearm that it is unloaded and the action locked open.

12. SHOOTING IN THE RANGE:

- Only one shooter in booth at a time, (exception, shooters under 18).
 - All additional people in your party are to wait behind orange line on floor.
 - Keep all firearms in your assigned booth and do not exchange firearms with another lane.
 - Before switching shooters, always unload and lock open the action before changing shooters.
- NEVER HAND SOMEONE A LOADED FIREARM.**

13. NEVER GO BEYOND FIRING LINE:

- Always keep firearm pointed down range, even when you set it down.
- If you have a dropped target, mag, firearm, or ammunition safely notify the RSO Officer. Going beyond the firing line resorts in immediate suspension from the range for 6 months or loss of membership.

14. LOADING & UNLOADING FIREARMS:

- On Firing Line (shooting booth) **ONLY** while pointing the firearm down range.
- **DO NOT** insert magazines into firearms or ammunition into a revolver until the firearm is in the booth and pointed down range.
- Magazines can be loaded in the ready area and brought to the firing line.
- Ammunition, magazines, range bags and other gear can be kept in the ready area.

15. TARGETS:

- Make sure that the angle of your shooting is so that your round does not impact the ceiling, floor, or side walls.
- Targets must be placed at eye level to ensure shots hit the bullet trap. No cross lane shooting.
- Shooters, at Range 406 discretion, are held FINANCIALLY RESPONSIBLE for any damage they cause to the range and or equipment, regardless of intent.

16. MULTIPLE ROUNDS FIRED:

- CONTROLLED double tap is permitted. **NO RAPID FIRING.**

17. DRAWN FROM HOLSTER:

- **DO NOT** draw from holster.
- **NO** cross-draw, shoulder or leg holster draw permitted.

18. FIREARM MALFUNCTION:

- For any firearm or ammunition problems, keep the firearm pointed down range and get assistance from an RSO.

19. CLEANING OF FIREARMS:

- **NO** Cleaning of firearms in the range, retail area or parking lot. We are not responsible for lost parts.

20. ALCOHOL & DRUGS:

- **NEVER** be under the influence of alcohol or drugs (Including prescription drugs that may alter ones behavior) while shooting at the range.
- Any person that appears to be intoxicated, under the influence or otherwise appears to be in a condition that would render them unsafe to handle and shoot firearms will not allowed to use the range and will be asked to leave.

21. DO NOT USE CELL PHONES:

- Cameras, or music devices while operating firearms in the range, and do not create any type of distraction that can cause a safety issue. **NO SELFIES**

22. SHOOTING MULTIPLE FIREARMS:

- If you are shooting more than one firearm only use one at a time.
- Make sure to use the CORRECT ammunition for the firearm you are shooting.

23. BRASS CASINGS:

- **NO picking up brass off the floor.**
- The fallen brass will be periodically pushed forward of the firing line to prevent falling hazards,
- ALL Handgun ammo must be brass cased. NO Aluminum or steel casings.

*Failure to abide by all of these rules or to act in a unsafe manner while on the range may result in you and/or your party being dismissed from the range. Violations, at Range 406 discretion, may result in cancellation of membership, and/or expulsion from Range 406.

***BREAKING RULE #4** and using incendiary, tracer rounds on the range will damage or cause a fire in the rubber berm. Using these types of rounds and putting the facility at risk will be considered and act of ARSON and Range 406 will be FORCED to contact the authorities in such case.
