








THERE ARE 3 DIFFERENT TYPES OF WEBSITE **FLIPPING**









Essentially you buy a fixer upper website with some potential, enhance it as quick as possible and sell it at a higher price. The choice of website is the most important element here.






Many people buy a website for its proven monthly recurring income and then develop that website as a long-term investment.
